A holder of the Plumber level II professional certificate:

- is familiar with the good building practice and ensures quality
- complies with occupational safety requirements for construction works
- is able to calculate the consumption of materials and the hours of work
- organises his/her work in compliance with regulations and in a safe manner
- reads architectural drawings
- stakes out the main building dimensions
- transfers height marks
- uses measuring instruments
- is familiar with general principles of construction and applies them
- is familiar with building materials and their properties
- is familiar with the main construction tools and machines
- is able to strop
- is familiar and complies with the safety requirements for work involving an open flame
- is familiar with the foundations of heat engineering
- is familiar with the foundations of hydraulics
- is familiar with the properties, processing and marking of the materials used for pipe production (metal pipes, plastic pipes, etc.)
- is familiar with the operating principles of environmental technology systems, equipment and appliances
- is able to use and maintain common tools
- has basic skills in metal-work and plumbing
- is familiar with the technologies and materials used for joining pipes
- prepares the building structures for the installation of the environmental technology systems
- is familiar with the principles, methods and equipment of leak search
- works with pressurised systems
- is familiar with, installs and maintains heating systems
- is familiar with, installs and maintains water supply systems
- is familiar with, installs and maintains sewerage systems
- is familiar with, installs and maintains gas supply systems
- welds
- is cooperative, has spatial imagination, is able to plan ahead, is accurate and diligent
