#### 3. PROFILE OF SKILLS AND COMPETENCIES

A holder of the professional certificate of a Make-Up Artist, level III:

- is able to work in a sustainable manner regarding the health of the customer and the environment
- is able to service a customer in his/her mother tongue and two foreign languages
- is able to communicate in a positive way with the customers, colleagues and employers
- has knowledge and is able to use the knowledge of facial anatomy and physiology, skin diseases and skin hygiene, substance chemistry, colour theory and lighting theory, history of make-up, fashion trends in make-up
- is able to prepare an analysis of face and use this knowledge for the creation of personalised make-up
- is able to make an analysis of the colour type and use this knowledge for the creation of personalised make-up
- knows and is proficient in the techniques of application of make-up products
- is able to colour eyebrows and eyelashes with permanent colours
- is able do design hair arrangements
- is able to apply make-up styles depending on the personality of the customer and the objective of make-up
- is able to sell and present make-up products
- is able to consider occupational health and safety and fire safety requirements and provide basic first aid
- understands the legislation related to the economic matters and the profession and labour law
- is able to perform make-up in accordance with a given sketch and to calculate the quantities of required make-up products
- is familiar with the make-up techniques for different light and shadow conditions
- is able to make, prepare and use wigs, additions, beards and other types of facial hair
- is able to identify the age associated with different realistic costumes
- is able to design historic hairstyles on the customer and on a wig
- is familiar with historic styles and is able to apply them in make-up
- is able to prepare prosthetic make-up additions from different materials (latex, foam-latex, gelatine, etc.)
- is able to supervise team-work
- has hairdresser's skills (also on wigs) cutting, dyeing, permanent waves
- is able to create face and body paintings

- presenter and seller of cosmetics and make-up products in a trade network
