3. PROFILE OF SKILLS AND COMPETENCIES

The holder of the I level of certificate for Cleaner:

- can perform his/her duties in the way that facilitates preservation of the health, environment and resources allocated to him/her
- follows occupational and fire safety requirements, can perform simple first aid procedures, understands employees' rights and obligations
- performs the duties assigned to him/her flexibly and is able to communicate with colleagues and the manager of cleaning operations
- can plan practical arrangement of cleaning equipment in the store room and maintain the equipment
- is familiar with the classification of dirt and most common surface coating materials (PVC, linoleum, parquet, laminate etc) and can select the most appropriate method of cleaning to be used
- can use common cleaning equipment (mops, wipes, brushes etc)
- is familiar with the classification of cleaning agents, can dose cleaning agents and select the most suitable agent to be used in the particular situation
- uses different cleaning methods (dry, moist, wet, damp) as required
- uses common cleaning machines (wet and dry vacuum cleaner, integrated floor maintenance machine, floor maintenance machine) under supervision; is familiar with their operation and maintenance principles and can operate the machines safely:
- can clean the most common types of room, including the furnishings, floor, walls and ceiling
- can clean windows, mirrors and other glass surfaces in circumstances where technical aids (hoists, ladders etc) are not required
- can sort wastes, is familiar with environmental labels and hazardous waste.
