Physiotherapist level 7 is an expert of health care and social field implementing high level clinical thinking, evidential professional knowledge and skills in his or her work. Physiotherapist solves different routine and complicated physiotherapeutic problems. Physiotherapist instructs students of physiotherapy in clinical practical work and/or advises other specialists of the same field or other profession. Physiotherapist forms and leads a team, in case of need. Physiotherapist makes professional presentations or develops professional instruction materials and represents and develops his or her profession in local as well as in international context. He or she analyses and synthesizes new professional ideas and development trends, participates in carrying out of scientific research and values the life-long learning.
