3. PROFILE OF SKILLS AND COMPETENCIES

A florist of level 4 is a skilled worker whose main job is to prepare plant material, create flower arrangements (incl. decorating), plant maintenance and arrangement of sale and customer service. He/she organizes one's own work independently and arranges team work. A florist of level 4 takes responsibility for development of others and for one's own and the team's work performance. The work of a florist requires stress tolerance, the skill to communicate with customers and colleagues, and solve problems. A florist of level 4 forms a positive image of the profession in everyday work and potentially participates in the activities, competitions, etc. of professional associations. He/she is capable of developing, open to new learning and passing on new duties, methods and techniques. He/she is capable of adapting one's communication style to different situations and people. The florist shows respect regarding cultural and religious differences.

Competencies:

- Preparing seeds and planting surface for sowing and planting
- Care of horticultural plants
- Harvesting, storing and preparing the crop or production for sale
- Planning of work
- Preparation and care of plant material
- Creation of flower arrangements, incl. decoration
- Arrangement and organization of sale
- Selling and customer consulting
- Management and supervision
