3. PROFILE OF SKILLS AND COMPETENCIES

Competencies:

- Planning one's own future activity by taking into account the initial task, the quality of blanks, the processing complexity and options of the woodworking bench
- Using information from the working drawings and process charts for finding blanks
- Checking the condition of cutting tools and their conformity to operation
- Configuring woodworking bench by taking into account the working drawings, process chart and given instructions (technological documentation)
- Sawing, dressing, drilling, milling, turning and polishing components by taking into account the working drawings, process chart and given instructions (technological documentation), by applying ergonomic and safe work techniques
- Assessing the conformity of the component to the quality requirements given in the work task by measuring, marking and using calibres and reference standard components
- Organizing and cleaning the bench on a daily basis in accordance with the requirements
- Using one's working area purposefully and keeping it in order, using materials and tools prudently and economically
- Following requirements of occupational safety and work environment and using occupational health and safety equipment
