3. PROFILE OF SKILLS AND COMPETENCIES

Organization of reforestations:

- Transports and preserves plants, taking into account the plant types and requirements for preservation;
- Evaluates visually the quality of reforestation material and prepares plants for planting depending on the plant type:
- Organizes reforestation, taking into account the conditions set for the area to be reforested and the type of the reforestation material;
- Evaluates the quality of work and compliance with requirements on the assumption of work tasks (holding strength of plants in the soil, planting depth, selection of planting location, and initial density of planting).

Maintenance of reforestation and cleaning activities

- Verifies the correctness of the working area using a map and/or GPS device:
- Selects trees to be left growing on the assumption of objectives related to the silviculture (improving site conditions of trees, forming the composition of the future forest stand, ensuring optimal distance between the trees, etc.);
- Fells trees unsuitable for the composition of the future forest stand, using brush saw or chain saw and avoiding damaging the trees that are left growing:
- Maintains the brush saw or chain saw, following the user manual;
- Evaluates the quality of work in view of the quality of trees suitable for the composition of the future forest stand, the quantity of trees per hectare and the distance between the trees, as well as compliance with requirements according to the work task.

Performing improvement cutting and regeneration cutting:

- Verifies the correctness and safety of the felling area, using a map and/or GPS device:
- Selects trees to be left growing on the assumption of objectives related to the silviculture (improving site conditions of trees, forming the composition of the future forest stand, ensuring optimal distance between the trees, etc.):
- Produces the timber assortment in accordance with the requirements set in the production target for the quality and parameters by using a chain saw;
- Maintains the chain saw as necessary according to the user manual;
- Evaluates the quantity of timber depending on the parameters of timber;
- Evaluates the quality of timber and the work on the basis of the work task.
