### 3. PROFILE OF SKILLS AND COMPETENCIES

A laboratory assistant of level 4 analyzes the composition and properties of substances and mixtures using the methods of chemical, physical and physico-chemical analysis.

A laboratory assistant works in testing laboratories (industrial, environmental protection, scientific, research, synthesis etc laboratories). The professional standard does not apply to calibration laboratories.

A laboratory assistant checks the quality of raw material, reagents, intermediate products, finished goods, waste, water, air and soil, and synthesizes different substances.

After special training he/she may find employment in microbiological and medicine laboratories.

A laboratory assistant works in a team, he/she is individually responsible for performance of his/her duties.

A laboratory assistant proceeds from methods and instructions, he/she is responsible for the reliability of his/her analysis results and for the precision of the data documentation.

#### Competencies:

- Preparation of tests;
- Sampling and preparing for analysis;
- Performance of the test;
- Documentation.
