# 2. TRANSLATED TITLE OF THE CERTIFICATE (1) Leather craftsman, level 4 (1) if applicable. This translation has no legal status.

### 3. PROFILE OF SKILLS AND COMPETENCIES

Leather craftsman of level 4 makes high quality and aesthetic leather handicraft objects according to his/her own working drawings or prescribed sketch designs, working instructions or simpler objects, using essential traditional and contemporary techniques, work techniques and ways of making.

A leather craftsman can perform cut out of the leather, attenuate the leather with knife or machine, make simpler forms and cover them with leather, join the details by sewing, integrating, gluing and riveting, and decorate and finish leather objects. In addition to main skills he/she has acquired at least one of the following special skills:

skills of making accessories (e.g. usual bags, straps, mittens, caps), clothes (e.g. waistcoat, skirt according to simple cut), footwears without last (e.g. heelless peasant shoes), fitments (e.g. pillows, seat covers), leather forms (e.g. cases, boxes) and book bindings.

Leather craftsman assumes responsibility for performance of one's work tasks, in case of more complex tasks he/she may need the help of the master.

He/she is ready to supervise his/her co-workers and trainees within limits of his/her skills.

A leather craftsman follows the ethical requirements of the handicraft master and follows the rules of the work safety and environmental safety.

A leather craftsman finds employment in leather processing company, leather sewing workshop, bookbindery etc, he/she is ready to act as entrepreneur, market his/her production, communicate with the clients and provide services (e.g. making objects according to prescribed sketch designs, repairing leather objects, making a subcontract and supervising the amateurs within limits of his/her skills).

A leather craftsman may become master by self-developing or learning in the institution of applied higher education and act as conservator, furnisher etc.

### Mandatory competencies:

- Making leather handicraft objects
- Preparation of construction drawings and reading of sketch designs;
- Sourcing and using of materials;
- Preparation of work;
- Preparation and use of work equipment and devices;
- Creating ergonomic and safe working environment;
- Making and finishing of the object.
- Marketing of leather products and services
- Formation of products and services;
- Marketing of products and services.
