3. PROFILE OF SKILLS AND COMPETENCIES

A motor vehicle diagnostics technician performs diagnostics and repair work of passenger cars, trucks, buses and mobile machinery, analyses the failure cause, finds and corrects faults.

He/she works independently and, if required, uses databases, catalogues and instructions of repair work. As a contractor, he/she bears responsibility for work safety and dangerous traffic situations that occurred as a result of maintenance and/or repair work.

Constant professional development is essential.

A diagnostics technician may work alone and as a team member. His/her work presupposes communication with co-workers and customers.

If required, he/she supervises the work of a motor vehicle technician. He/she guides and gives instructions for diagnosing faults.

He/she supervises and helps to analyse the data collected by the technician for determining and mapping a more specific scope of repair work.

- Diagnostics and repair of engine electronics
- Diagnostics and repair of transmissions
- Diagnostics and repair of bus networks
- Diagnostics and repair of electrical devices and comfort systems
- Diagnostics and repair of control gear and chassis
- Diagnostics and repair of air conditioning systems
- Diagnostics and repair of safety devices
- Diagnostics and repair of hydraulic and pneumatic operational equipment of motor vehicles
- Diagnostics and repair of operational equipment of motor vehicles and their attachment mechanisms
- Handling of air conditioners
- High voltage power installations of motor vehicles
- Gas appliances of motor vehicles
