3. PROFILE OF SKILLS AND COMPETENCIES

The work of a chorus conductor is creative, presupposing musical training. A chorus conductor is interpreter of vocal music whose work tasks include teaching songs to the chorus and performing them in concert. The objective of the work is artistic conducting of the chorus and providing a high class musical experience to the audience. The work of chorus conductor is essentially pedagogical and presupposes, in addition to the musical skills also independent work with the chorus and knowledge of methodology and psychology.

Conductor, EstQF level 7, generally works as conductor. He/she is a recognised specialist who is invited to conduct joint choruses in song days and/or song festivals, national song festivals or is the category conductor/art director. Is valued in chorus voice placing and a specialist of chorus vocal work.

Participates with his/her chorus(es) in competitions, festivals and performs concerts. Choruses are actively involved in concert activities. Conducts seminars, provides training as a mentor, finds the necessary training methods and, if necessary, draws up study materials. Participates in competitions as jury member.

Manages musical projects (art director in song festivals, song days, gala concerts).

Mandatory competencies:

- Preparation of repertoire;
- Learning, rehearsal and recital of the repertoire;
- Work with repertoire;
- Creative direction of the chorus.

Optional competencies:

- Promotion of chorus movement;
- Organisation of concert projects
- Work with vocals
- Teaching of solfeggio
- Creation of music;
- Use of music notation and music softwares;
- Administration of the chorus.
