## 3. PROFILE OF SKILLS AND COMPETENCIES

Whitesmiths work in enterprises that manufacture construction materials and in construction enterprises. They build proper seam roofs and corrugated sheet metal roofs and facades that comply with requirements and install sheet metal components.

Tasks also include building of a subroof, installing rainwater systems and maintaining and repairing existing roofs.

Manufacturing of sheet metal components

- Preparing a sketch or template of the component
- Manufacturing sheet metal components in the workshop or on site
- Connecting components

Installing underlay and roof boarding on roofs and walls

- Installing underlay on roofs and walls
- Installing roof boarding on roofs and walls

Preparing the workplace and storing of necessary materials

- Preparing the workplace, lifting and storing materials on roofs
- Loading and fixing of materials
- Covering of materials

Installing rainwater systems with suspended gutters

- Determining the necessary quantity of components
- Performing measuring work
- Installing rainwater systems

Installing corrugated sheet metal roofs and facade components

- Installing ready-made components on corrugated sheet metal roofs
- Installing sheet metal components on facades

Installing seam roofs

- Accounting of necessary quantity of materials
- Processing of pre-seamed panes and manually seamed components
- Installing pre-seamed panes
- Installing manual rolled components
- Installing on-roof gutters

Advising and supervision of less qualified whitesmiths

- Assessing work-related environmental risks and advising of the person being supervised
- Advising of analysis and correction of mistakes detected while performing work
- Supervision and advising of less qualified whitesmiths in performing tasks
