3. PROFILE OF SKILLS AND COMPETENCIES

The purpose of chimney sweeper's work is to ensure fire safety, economizing heating mode and clean human environment by cleaning and maintenance of heating installations and sharing information. Tasks of a chimney sweeper, EstQF level 3, include checking and cleaning the fire safety of heating and ventilation system in individual houses, summerhouses, garden houses, farmhouses and small buildings, and, under supervision of a master chimney sweeper, eliminates blockages. He introduces to the public the installation and maintenance requirements and safe usage of heating installations and informs them about discovered shortcomings.

A chimney sweeper gives an assessment for the existing heating systems.

Chimney sweeper, EstQF level 3, works in normal situations independently, if necessary as part of team and under supervision of a master chimney sweeper.

A chimney sweeper follows requirements of professional ethics and practice of good behaviour.

Competencies:

- Planning and documentation of work
- Cleaning of heating systems
- Notification and advice
