3. PROFILE OF SKILLS AND COMPETENCIES

A childminder has acquired the knowledge and skills necessary to take care of children and support their development. A childminder shall cooperate with the parent or guardian.

The purpose of the work of a childminder is to support the physical, emotional, intellectual and social development of a child, taking into account the needs of the family in minding the child.

In their work, they shall be guided by the law, the welfare and safety of the child.

The work of a childminder requires good mental and physical health. In their work, they shall follow a code of professional ethics and be guided by constant self-development and acquiring new knowledge.

Mandatory competences:

- 1. Supporting the growing environment of the child
- Creating a safe and playful growing environment
- Assessing and preventing hazards.
- Noticing abuse.
- Doing household and cleaning works.
- Using household equipment and following safety requirements.
- 2. Supporting the development of the child
- Supporting the development of the child's playing, perception, learning, social and age-appropriate skills.
- Supporting the language and speech of the child.
- Understanding the personality and development of the child.
- Developing the values and good behavioural practices of the child.
- Planning, conducting and analysing games and activities.
- Supporting the creativity of the child.
- 3. Developing reflexive skills of the child
- Developing self-serving skills.
- Teaching the child to eat and assisting the child in eating if necessary.
- Developing the skill of self-regulation.
- 4. Promoting the health of the child
- Monitoring the health condition of the child.
- Determining factors which damage the child's health and preventing dangerous situations.
- Conducting activities which promote the child's health.

The format of the description is based on the following texts: Council Resolution 93/C 49/01 of 3 December 1992 on the transparency of qualifications, Council Resolution 96/C 224/04 of 15 July 1996 on the transparency of vocational training certificates, and Recommendation 2001/613/EC of the European Parliament and of the Council of 10 July 2001 on mobility within the Community for students, persons undergoing training, volunteers, teachers and trainers.
