3. PROFILE OF SKILLS AND COMPETENCIES

Vehicle technician services, repairs, provides general diagnostics and troubleshoots motor vehicles, non-road mobile machinery, construction machinery, platform, small machinery, motorcycles, motorized manual machinery, technological machinery, bicycles, trailers, and the add-in and the work equipment (hereinafter referred to as the vehicles, machinery). Vehicle technician works independently, using, if necessary, repair databases, directories and manuals. As a contractor, the vehicle technician is responsible for occupational safety and for dangerous situations in traffic resulting from service and/or repair. Because of rapid development of technology continuous self-improvement is required. Vehicle technician may work both alone and in a team, the job requires communication with co-workers and clients.

Work components:

- General diagnostics, service and repair of motor vehicles
- General diagnostics, service and repair of the body, interior and superstructure
- General diagnostics, service and repair of the engine
- General diagnostics, service and repair of power transmission
- General diagnostics, service and repair of electrical equipment and convenience systems
- General diagnostics, service and repair of control panels and chassis
- General diagnostics, service and repair of air conditioning equipment (heating, ventilation and cooling equipment of the passenger cabin)
- Handling of air conditioning systems

Specialization depends on the vehicle category/type and intended use as follows: passenger car technician, truck and bus technician (commercial vehicle), mobile machinery technician and small machinery, motorcycle and bicycle technician.

Work components related to the specialization:

Truck and bus equipment

- General diagnostics, service and repair of trucks and buses and their standard and additional equipment Mobile machinery equipment
- Assessment of the condition and service of the superstructure of mobile machinery equipment, its operational and additional

Small machinery, motorcycle and bicycle equipment

Service and general diagnostics of motorcycles and motor equipment.

This document is designed to provide additional information about the specified certificate and does not have any legal status in itself. The format of the description is based on the following texts: Council Resolution 93/C 49/01 of 3 December 1992 on the transparency of qualifications, Council Resolution 96/C 224/04 of 15 July 1996 on the transparency of vocational training certificates, and Recommendation 2001/613/EC of the European Parliament and of the Council of 10 July 2001 on mobility within the Community for students, persons undergoing training, volunteers, teachers and trainers.
