#### 3. PROFILE OF SKILLS AND COMPETENCIES

Harvester operator, the level 4 is a skilled professional, who performs work related to forestry and harvesting and appreciates the natural environment. He operates a harvester, knows its technical design maintenance principles.

The harvester operator chooses trees to be cut based on the forest management decision and cuts, debarks and cuts to length the trunks into the assortment with the required quality and parameters, ensuring an optimal economic outcome and the ecological and economic forest sustainability.

In his/her work the harvester operator takes into account preceding and subsequent work phases, their smooth succession and the requirements for the wood and haulage roads.

#### Work components:

- 1. Maintenance and regeneration cutting
- Operation of forest machinery
- Verification of the accuracy of the cutting area
- Preparation of the cut-to-length file
- Selection of trees to be cut
- Production of wood assortment
- Consolidation of wood assortment and reporting
- Conducting control measurement of the harvester
- Reception and transmission of electronic data
- 2. Adjustment and maintenance of the harvester
- Monitoring the technical condition of the harvester
- Maintenance of cutting units of the harvester
- Assessment of harvester's need for maintenance and repair
- Handling of maintenance and repair waste
