3. PROFILE OF SKILLS AND COMPETENCIES

Level 6 Construction Site Manager works as construction works manager and specialist in charge at construction sites. As Construction Site Manager, management skills are also important in addition to construction-related knowledge and skills. Construction Site Manager is responsible for the technical and economic activities on the site and, where appropriate, for safety at the construction site. He manages construction work, organises meeting (with subcontractors, contracting entities, clients and designers) and verifies whether the work has been done in compliance with project documentation and construction standards.

Construction Site Manager can specialise in the following areas of activity:

- General Building Construction
- Construction of Technical Systems
- Exercise of Owner Supervision

Competencies:

- Preparation of construction tender
- Preparation and planning of construction
- Resource management
- Management, organisation and coordination of construction works at the construction site in accordance with the work schedule.
- Assuring work safety at construction sites
- Ensuring the quality of construction works
- Transfer of construction works and the entry into use of the building
- Energy-efficient construction
