

OCCUPATIONAL QUALIFICATION STANDARD

Beautician, EstQF Level 5

An occupational qualification standard is a document which describes the set of skills, knowledge and attitudes, i.e. competence requirements, needed to successfully accomplish duties. Occupational qualification standards are used for compiling curricula and awarding qualifications.

Part A DESCRIPTION OF WORK

A.1 Description of work

The job of a beautician is to improve the client's aesthetic appearance, taking into account their needs and wishes and the options available to them. The beautician is personally responsible for the end result and, where necessary, guides colleagues.

Their job responsibilities include facial care, depilation, make-up and caring for the hands, feet and body.

They advise clients regarding the selection and use of appropriate beauty products and recommend products that can be used at home based on the salon treatment. The work of a beautician requires knowledge of the appropriate equipment to use when performing various procedures, a purposeful and creative attitude and good communication skills.

The beautician's job requires constant self-improvement. They are aware of trends and are able to recommend treatments based on the client's personality.

A.3 Work environment and specific nature of work

A beautician mostly works seated and in other forced positions. Working hours are flexible and work can be carried out on weekends and in various environments. A beautician may come into contact with allergens.

A.4 Tools

A beautician's tools include spatulas, brushes, blackhead extractors, tweezers, files, electric tools, disposable tools, disinfectants and auxiliary and personal protective equipment for various treatments.

A.5 Personal qualities required for work: abilities and characteristics

Important characteristics are empathy, tolerance, responsibility, cooperation, analytical thinking and adaptability. The work requires correctness, stress tolerance, physical ability, a purposeful and creative attitude towards work and good communication skills. A beautician needs to have good manual dexterity, fast and precise movements and good coordination.

A.6 Professional preparation

A beautician needs to have at least secondary education and to have completed professional training.

B.1 Structure of occupation

Mandatory competences B.2.1 - B.2.5 and recurring competence B.2.9 must be certified when applying for the qualification of Beautician, Level 5. In addition, at least one competence from elective competences B.2.6 - B.2.8 should also be certified.

B.2.4 Customer service Performance indicators:

- 1. creates a positive first impression by acting kindly, politely and professionally;
- 2. expresses an interest and listens to the client's wishes and expectations regarding the service, introduces the products and services offered to the customer and answers questions clearly;



creates a private, secure, open-minded and comfortable atmosphere, respecting the client and their cultural background, recognising each individual client as an individual and taking into account the client's mood and feelings;
 behaves adequately and creatively in different service situations, reduces negative emotions and quickly adapts to different situations; does not lose self-control and controls their body language;

5. provides the client with an overview of the treatment;

6. advises the client and is supportive of their wishes, without affecting the client's well-being;

7. recommends products for home skin care, taking into account indications and contraindications.

B.2.5 Entrepreneurship	EstQF Level 5

Performance indicators:

1. evaluates business opportunities based on the objectives of their operations; selects the most suitable form of enterprise; manages their activities taking professional information, legislation and the basics of small enterprises into account;

2. prices services based on operating costs and the market situation; prepares a salon budget based on expenses and revenue; adheres to budget implementation; organises the purchasing of the necessary products and consumables; manages the customer base in compliance with legislation;

3. prepares sales and marketing campaigns based on the concept of the salon; puts together loyalty programmes; 4. plans working hours and produces work schedules.

In addition, at least one competence from elective competences B.2.6 - B.2.8 should also be certified.

B.2.6 Hand and foot care EstQF Level 5 Performance indicators: 1. propares the client for hand and foot care; visually assesses and analyses the condition of the skin and nails

1. prepares the client for hand and foot care: visually assesses and analyses the condition of the skin and nails, and changes in the structure of the feet; identifies indications and contraindications; plans the order in which to carry out the work according to the selected treatments;

2. filing and shaping of the nails according to the client's wishes, ensuring an aesthetic result, using a pedicure drill, where necessary; cleans the cuticles using appropriate products, tools and techniques; removes hard skin using a scalpel, rasp or pedicure drill;

3. massages the hands and feet according to indications using classic massage techniques and appropriate products;

4. exfoliates the skin with suitable products, moisturises the skin, applies masks and performs paraffin treatment with hot and cold paraffin;

5. varnishes the nails according to the client's wishes, using classic and gel polishes.

B.2.7 Body treatments

Performance indicators:

1. prepares the client for body treatments; visually assesses body and skin condition, identifying indications and contraindications; where necessary (e.g. in the case of malignant birthmarks, fungal skin and nail diseases, skin ulcers, inflammation and acne), refers the client to a dermatologist for consultation;

2. plans treatments based on the client's needs, wishes, indications and contraindications;

3. cleans, exfoliates, tightens and moisturises the skin, applies wraps and masks and relaxes muscles according to the treatment using appropriate tools, techniques and products;

4. performs back and general massage using appropriate techniques, taking into account indications and contraindications.

B.2.8 Make-up

2. provides day and evening make-up using different styles, appropriate products, tools and techniques, taking into account the client's wishes and the shape of their face;
