3. PROFILE OF SKILLS AND COMPETENCIES

Competences:

- Cutting wood or wood-based materials on CNC processing centres
- Planning one's own further activities by taking into account the initial task, the drawing and program prepared for the product manufacturing, the quality of workpieces, complexity of processing and the possibilities of the centre
- Using information from the working drawings and process charts for finding workpieces
- Checking the condition of cutting tools and their conformity to operation
- Starting and configuring a CNC processing centre according to the manufacturer's instructions (technological documentation), selecting a suitable program from the existing ones and setting up the desktop according to the instructions
- Manufacturing components by using auxiliary tools and templates according to given instructions (incl. technological documentation) if necessary
- Assessing the conformity of the component to the quality requirements given in the work task by measuring, marking and using calibres and reference standard components
- Distinguishing error messages of the machine tool and reacting to them by taking into account the manufacturer's instructions
- Saving the error messages and technical repairs by filling in the necessary documents
- Stopping the CNC processing centre pursuant to manufacturer's instructions
- Organizing and cleaning the machine tool on a daily basis in accordance with the requirements
- Using one's working area purposefully and keeping it in order, using materials and tools prudently and economically
- Complying with the working environment and occupational safety requirements by using occupational health and safety equipment and safe operating techniques
