A beekeeper works independently, is sustainable in his/her work, innovative and plans one's working hours and tasks. His/her work requires knowledge and entrepreneurship for an apiary management. A beekeeper can anticipate success and possible setback, evaluate and analyse one's activities to find necessary solutions.

In the production process of beekeeping products the beekeeper contributes to natural reproduction, conservation of biodiversity and preservation of the environment.
