3. PROFILE OF SKILLS AND COMPETENCIES

The main tasks of the stove-setter consist in construction, installation and renovation of solid fuel heating systems. The solid fuel heating systems include masonry heating installations from bricks, different tiles and blocks, quarry stone or other materials operating on solid fuel (stoves, cooking ranges, fireplaces, etc.) and the related systems (flues, chimneys, etc.) as well as ready-made heating installations and chimney systems of the liability of producer (e.g. lightweight fireplaces for warm-air heating, sauna stoves).

The master stove-setter of level 5 builds and renovates different solid fuel heating installations and chimney systems and installs and repairs the ready-made heating installations and chimney systems of the liability of producer.

He/she has the right to prepare expert assessments. The stove-setter at the master's level supervises and trains apprentice stove-setters.

If they so wish and after passing the required training, the master stove-setter of level 5 can specialise and obtain the occupational qualification of the master stove-setter/restorer.

The work of the master stove-setter of level 5 is based on the standard EVS 812-3, Fire safety of constructions, Part 3: Heating systems.

Mandatory competencies:

- Communication with the client and counselling, getting acquainted with the possibilities of the building site and building documentation;

- Design development of the heating system to be built and preparation of the preliminary building design documentation;

- Installation of the heating system or its parts of the liability of producer and preparation of the preliminary building design documentation;

- Building of solid fuel heating installation;

- Installation of the solid fuel heating installation of the liability of producer;
- Renovation or modification of the solid fuel heating installation or system;
- Renovation or modification of the solid fuel heating installation or system of the liability of producer;

- Giving expert assessment to a solid fuel heating system.

Competencies related to specialisation:

- Restoration of the heating system or its part.
